The ornamental design for a reconfigurable toy vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a reconfigurable toy vehicle showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view thereof, the side opposite being a mirror image;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is another front perspective view of the design shown in FIGS. 1 through 6 in a humanoid robot configuration;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a right side elevational view thereof, the side opposite being a mirror image;

 FIG. 11 is a top plan view thereof;
 FIG. 12 is a bottom plan view thereof;
 FIG. 13 is further front perspective view of the design shown in FIGS. 1 through 12 in another humanoid robot configuration;

 FIG. 18 is a bottom plan view thereof.

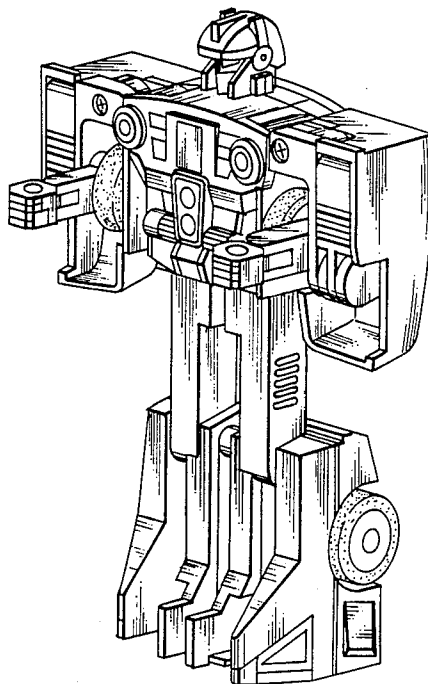
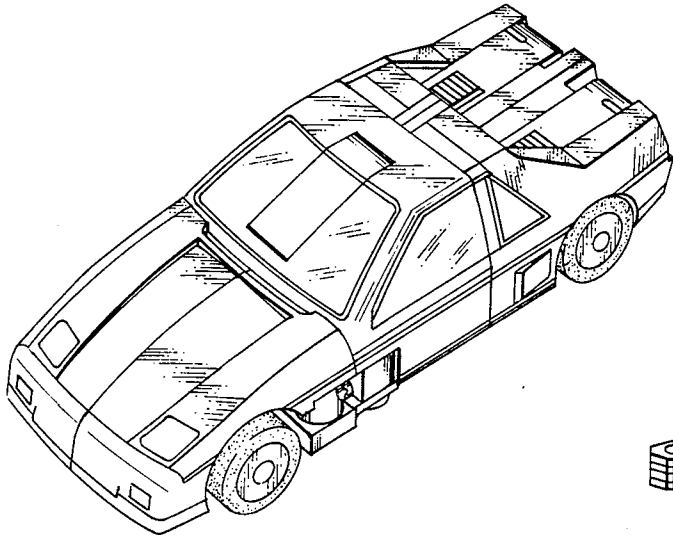

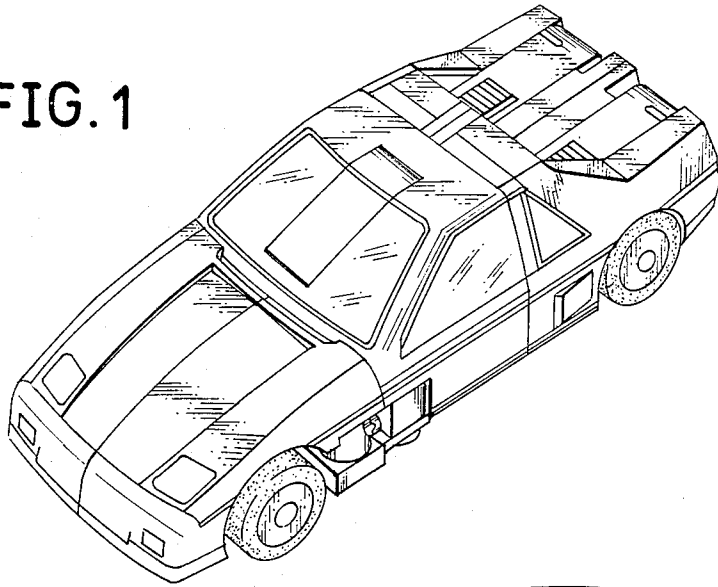

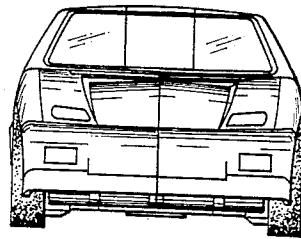

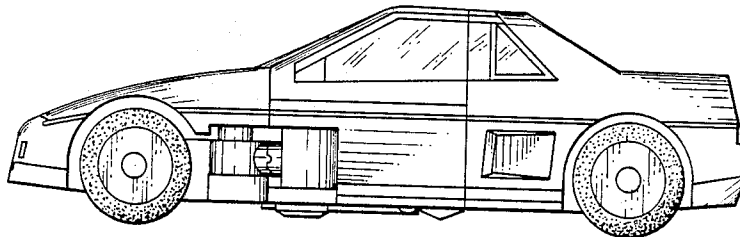

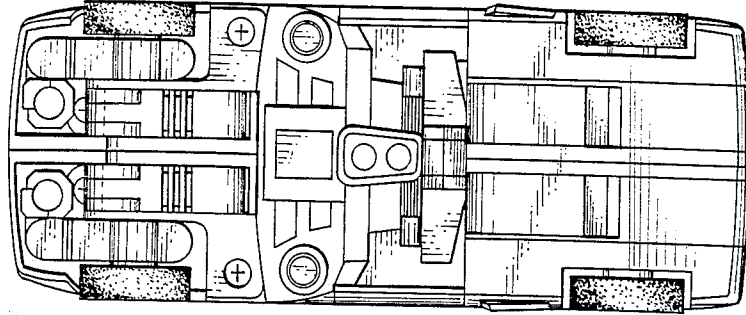

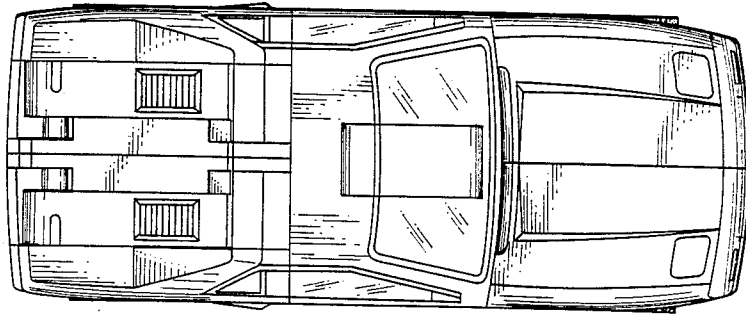
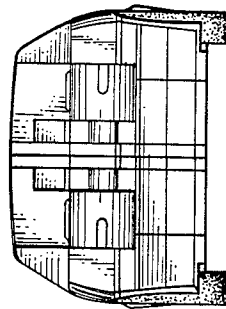

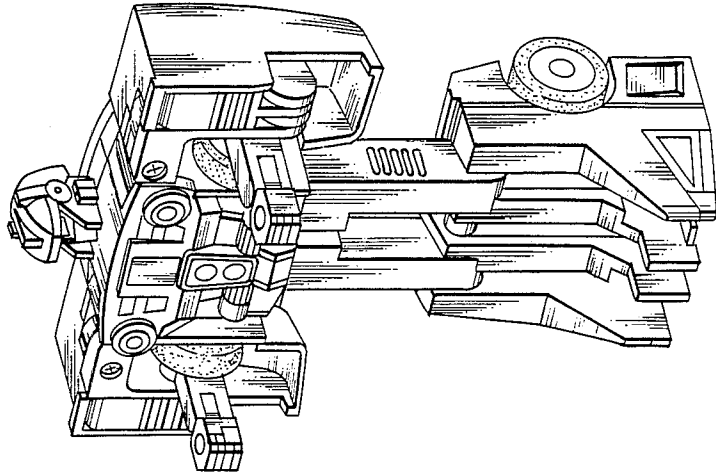

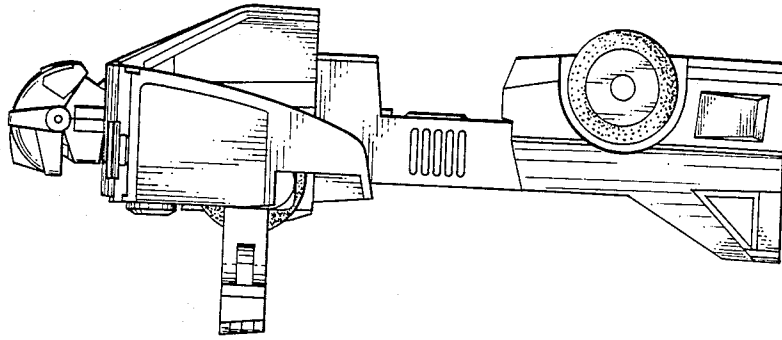

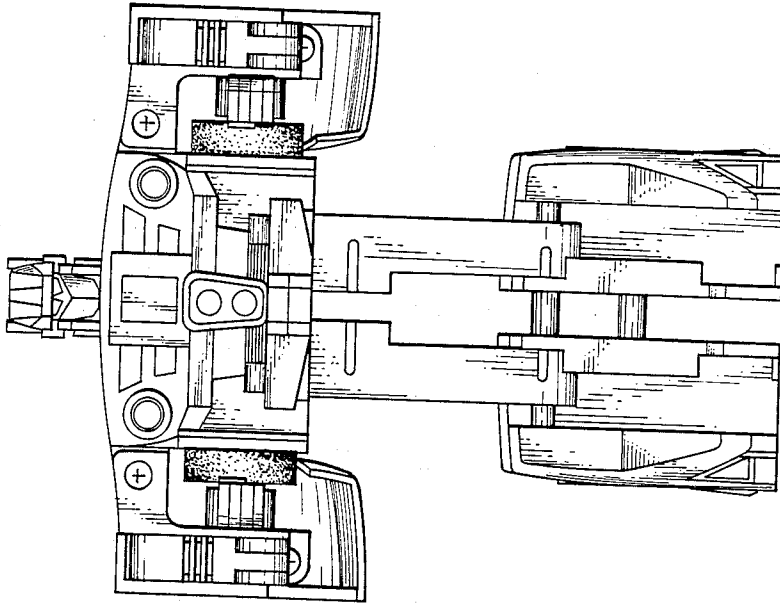

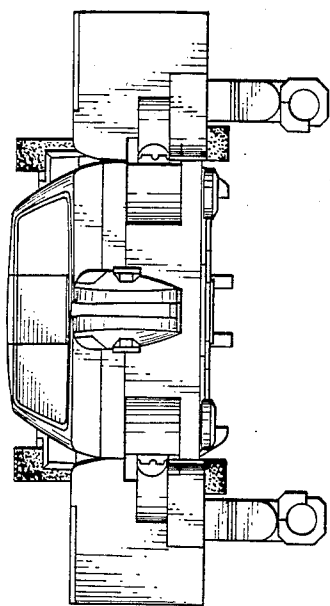
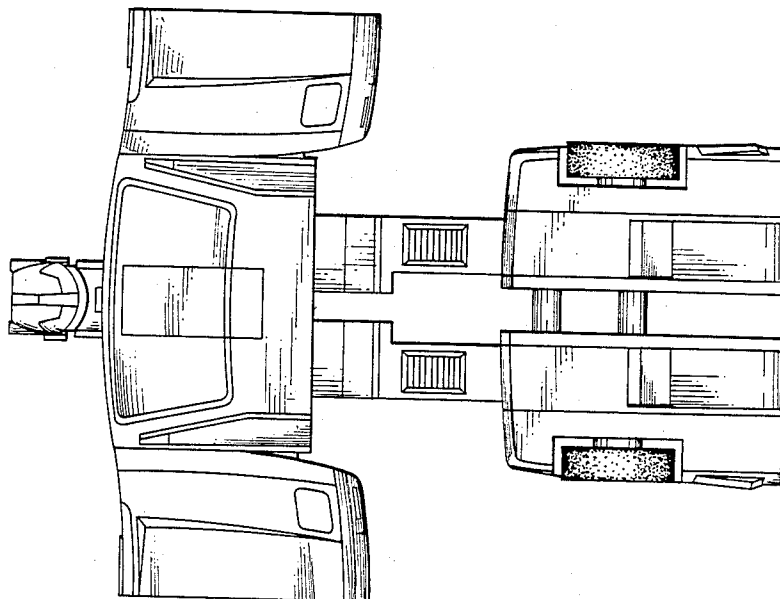

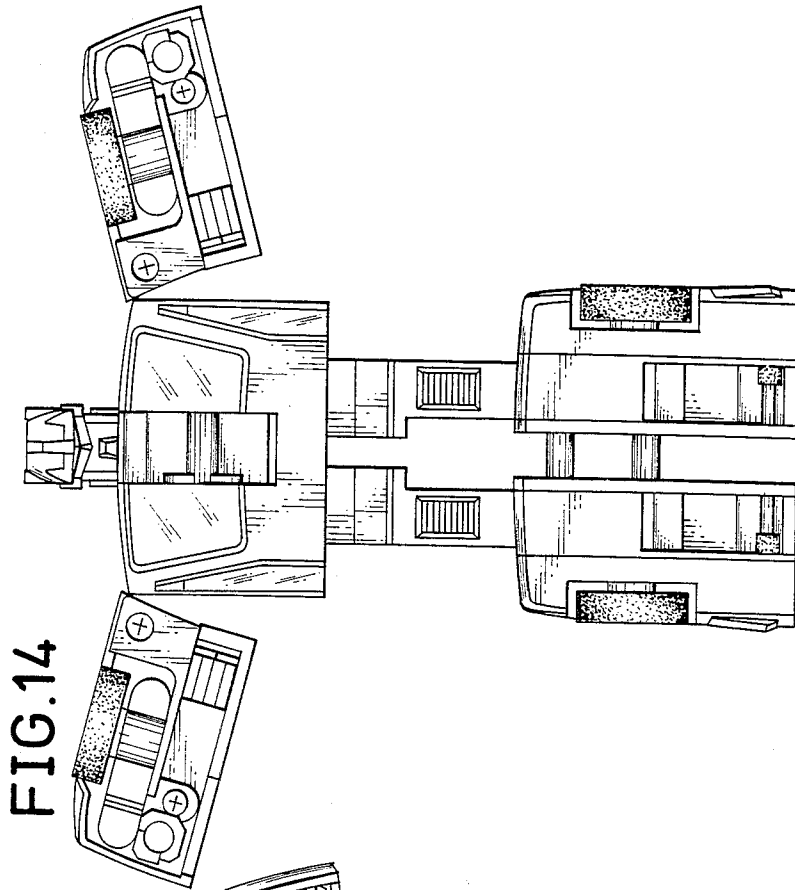

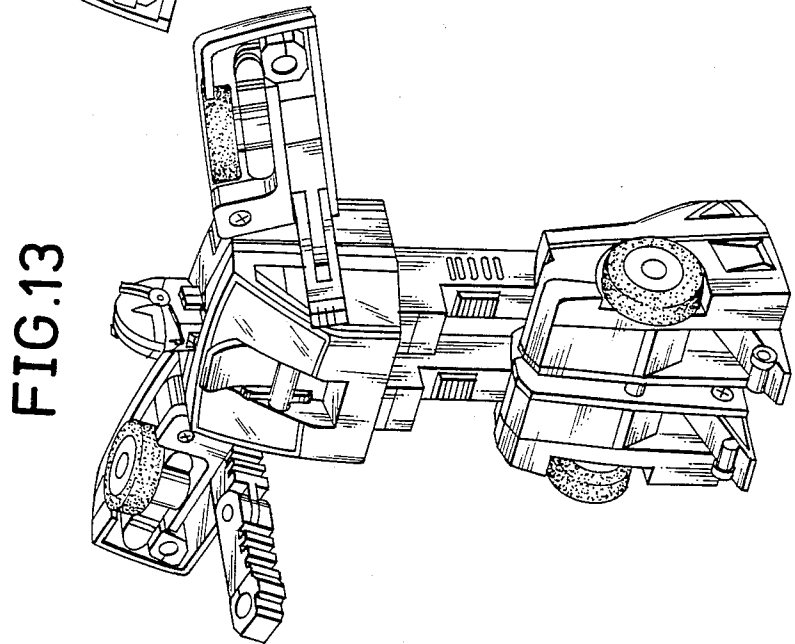

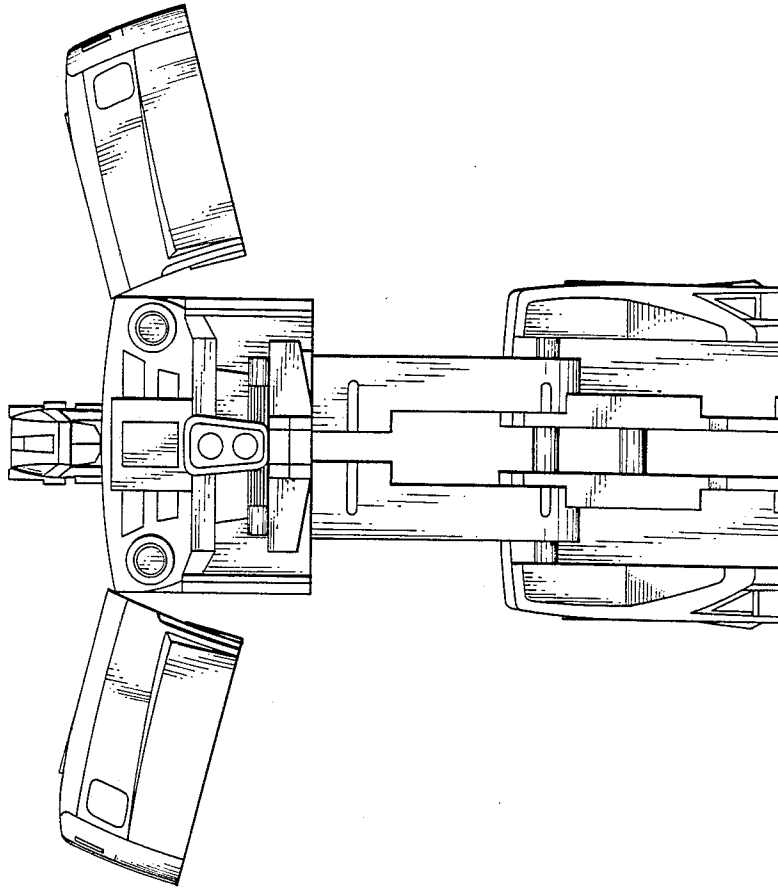
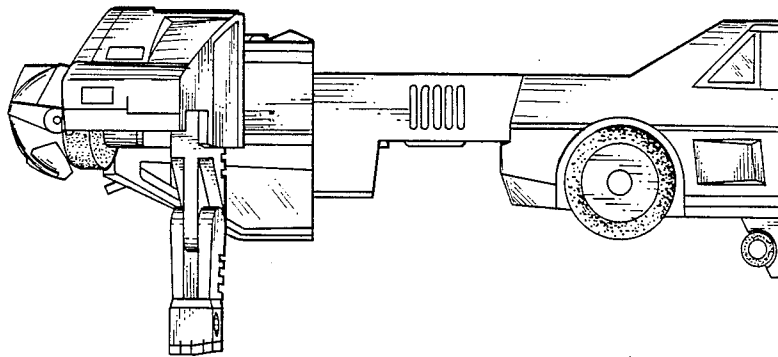

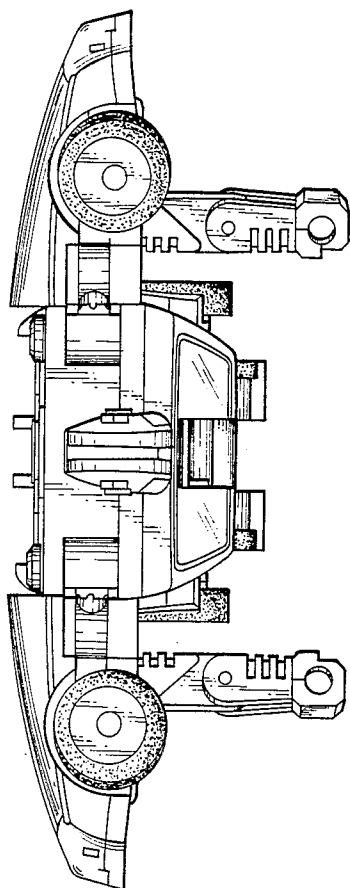

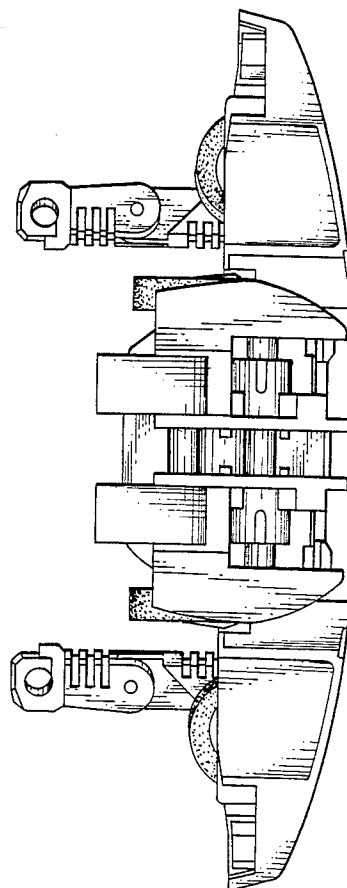
